Credit Card Fraud: #2010-6756

On July 6, 2010 at approximately 3:15 pm., loss prevention observed a subject enter the store that matched the description and photograph of a person wanted by the Pittsfield Department of Public Safety for credit card fraud. Loss prevention observed the subject along with two other subjects purchase high dollar amount gift cards using several credit cards. At that time loss prevention contacted the police department and upon officers arrival they located the subjects in the parking lot. The three subjects were arrested and lodged at the Washtenaw County Jail. The subjects have been charged with credit card fraud, identity theft, and stealing a financial transaction device.

Retail Fraud / Felonious Assault With A Motor Vehicle: #2010-6893

On July 9, 2010 at approximately 4:05 pm., Loss Prevention observed two subjects selecting and concealing merchandise inside of a bag. Loss Prevention followed the two subjects until one of the subjects exited the store without paying for the items. As loss prevention approached the subject in the parking lot the other subject that was in the store with her began driving her vehicle directly at loss prevention. The loss prevention officer immediately jumped out of the way into a flower stand in the garden section as the vehicle passed. Loss Prevention was then able to take into custody the retail fraud subject and identify the driver of the vehicle. The retail fraud subject was arrested by the Pittsfield Department of Public Safety and an investigation into the actions of the driver continues. The case will be forwarded to the Washtenaw County Prosecutor's Office for review.
