WEEKLY FIRE REPORT

August 27, 2010, # F-10-1622, 1500 block of Oakfield Drive, Weatherstone Condominium Fire Fighters responded to a report of a natural gas line struck by construction workers. On arrival, they found a 1-inch service line ruptured. Fire fighters stood by on the scene for DTE Energy crews to arrive and repair the damaged line. No injuries were reported. No evacuations were necessary.

Fire Fighters responded to a report of a vehicle fire on Southbound US 23 north of I-94. On arrival, they found a 1960's vintage Ford Mustang with extensive front end damage and a small fire burning in the engine compartment. The driver was confused with a traffic cone pattern placed for night road work. He drove into an area restricted to traffic, thinking it was the access to the I-94 ramps. While traveling at posted construction zone speed, he struck some asphalt and concrete piled in the roadway for removal. The driver was transported to the hospital by HVA for non life-threatening injuries.
