

## Petition for Action on Conditions of Pretrial Release

COMES NOW Susan D. Gilmore, PRETRIAL SERVICES OFFICER presenting an official report upon the conduct of defendant <u>JENSON</u>, <u>Stephen</u>, who was placed under pretrial release supervision by the Honorable <u>R. Steven Whalen</u> sitting in the court at <u>Detroit</u>, on <u>February 16, 2012</u>, under the following conditions:

Report to Pretrial Services as directed, travel restricted to the Eastern District of Michigan & Utah as approved by Pretrial Services, avoid all contact with any victim or potential witness in this case, undergo Sex Offender Treatment as directed, refrain from possessing a firearm or destructive device, participate in location monitoring and curfew as directed, no computer unless for work and Pretrial Services has installed monitoring software, no contact with minors.

Respectfully presenting petition for action of court and for cause as follows: (if short insert here; if lengthy write on separate and attach)

On October 16, 2012, it came to the attention of Pretrial Services that the defendant has been accessing a computer that is not monitored by Pretrial Services.

Additionally, the defendant is participating in the Location Monitoring Program which requires him to remain in his residence from 8 PM to 8 AM. On the following dates, the defendant has not returned home at 8 PM,

On April 12, 2012, the defendant did not return home at 8 PM, he returned home this same date at 9:22 PM (1 hour 22 minute violation)

On April 19, 2012, the defendant did not return home at 8 PM, he returned home this same date at 8:45 PM, (45 minute violation)

On May 13, 2012, the defendant did not return home at 8 PM, he returned home this same date at 8:53 PM, (53 minute violation)

On June 11, 2012, the defendant did not return home at 8 PM, he returned home this same date at 9 PM, (1 hour violation)

On October 01, 2012, the defendant did not return home at 8 PM, he returned home this same date at 11:17 PM, (3 hour and 17 minute violation)

As a result of the defendant's continued curfew violations, his curfew was adjusted on October 03, 2012, requiring him to return home every evening at 5 PM.

On October 13, 2012, the defendant did not return home at 5 PM, he returned home this same date at 5:34 PM (**34 minute violation**)
