Regent Fitzsimmons convened the meeting at 9:59am. Minutes of June 19, 2012 were approved as presented.

#### Introduction of SAAC Members

Members of the Student Affairs Advisory Committee introduced themselves.

#### Fall Start up Report

Melissa Ginotti, director of Campus Life, Marney Buss, director of Residence Life, BJ Selfridge, coordinator of Admissions Visit Programs, Matthew Jones, student, and Tashauna Culberson, student, presented the 2012 Fall Start Up Report. Here are a few highlights:

- New financial aid procedures have been implemented which allow prospective students to know what the potential scholarship offer is earlier in the process.
- Improvements have been made to Fast Track.
- Most residence halls are at capacity, with housing contracts up by 330 overall.
- More than 440 volunteers helped with move-in on Saturday. More than 150 New Student Orientation Assistants helped during the four day orientation.

 Fusion: First Four Orientation was held for FTIACs, Transfer, International, Graduate, Honors College and Veteran students.

#### **Student Government and Student Affairs Advisory Council Priorities**

Student Government has 13 priorities for the 2012-13 academic year. R. Matthew Norfleet and Desmond Miller shared the top three:

- 1) 24 hour access to a portion of Halle Library. This pilot program began on Sept. 10, 2012
- 2) Turbo Vote which makes voter registration and absentee voting accessible
- 3) EMU Town Halls which will provide a platform for student voices

The Student Affairs Advisory Council shared 2012-13 priorities. These include: Peer-to-Peer Book Exchange, Improved Wi-fi in the Residence Halls, Development of an Annual Event to Connect EMU and Ypsilanti, Winter Semester Student Activities Fair, Restructuring SAAC, Increasing Involvement of Transfer and Commuter students, Creating more Activities to Engage Students, Increasing Alumni Involvement, Beginning a Students with Disabilities Organization, and Implementing a Suicide Prevention Campaign. The SAAC will meet every other week to work on priorities. They will report on progress at the December 2012 meeting. This is not a concrete list – other items may be added.

Regent Fitzsimmons stated that she appreciates the Student Affairs Advisory Council and loves working with them. She believes that they have many great ideas.

#### **Medical Amnesty**

Gloria Hage, general counsel, Jesus Hernandez, director of Student Conduct and Community Standards, and R. Matthew Norfleet, Student Government president, presented a power point related to a change to the Student Conduct Code – based on House Bill 4393. The change will address the current code and make it consistent with state law. This change is being implemented to encourage responsible decision making, and remove barriers to seeking medical attention when needed. If an EMU student is underage and receives medical attention for excessive drinking, they may apply for Medical Amnesty. Sanctions will be deferred and they must meet with a health officer. If all requirements are met, they will receive a formal reprimand. This is a one-time option. If there is a 2<sup>nd</sup> violation, the Student Conduct Code will apply.

A Medical Amnesty awareness campaign to share this information with the student body is being planned.

Jesus recognized audience members who were involved in working on the code revision.

Regent Fitzsimmons asked if this change also relates to drugs. Jesus said that it applies only to alcohol.

#### **Announcements**


 Tara Lynn Fulton, dean of the Library, announced that EMU and U of M have entered into a reciprocal library borrowing agreement. This includes most of the U of M libraries (not the medical or law library.) EMU students must go to Halle to authenticate their library card before borrowing books from U of M libraries. Tara handed out brochures and stated that information is available on the Halle Library website. Regent Fitzsimmons thanked Tara and the staff of both libraries for the work on this agreement.


- R. Matthew Norfleet announced that 445 EMU students have completed the registration process for TurboVote. Matthew thanked Leigh Greden, Desmond Miller, Jasmina Camo-Biogradlija and Campus Life for help with this initiative. Students may sign up for this service at emich.turbovote.org.
- Reggie Barnes announced that September 15 October 15 is Latino Heritage Month. There are
  many events scheduled for this time. Reggie also shared that L.I.V.E Welcome Week, designed to
  engage first generation college students, was a success. There will be a BBQueer on September 18
  at Big Bob's Lake House. Reggie's goal is to work with leaders to draw attention to issues of
  diversity and inclusion. His desire is to be proactive, as opposed to reactive.
- Glenna Frank Miller announced that the SAAC voted to change undergraduate commencement regalia to dark green with EMU emblems on the lapels. The new regalia will be worn at the December 2012 commencement
- Provost Schatzel stated that she is honored to be part of the SAAC. She enjoys the interaction with students.
- Oona Friedland reminded everyone that the BBQueer is tonight. She also mentioned Outober which is national coming out month.
- Glenna Frank Miller recognized the contributions that Cathie McClure and Teri Papp have made to the Student Affairs Advisory Committee (Student Leader Group) over the years.

The meeting adjourned at 10:44am.



# Social Norms Campaign Goal:

• To reduce high-risk drinking of freshman students at EMU by fostering normative attitudes regarding alcohol use among first year students.

#### **Objectives**

- Collaborate with Academic Affairs and the School of Health Promotion and Human Performance (HPHP) to design, conduct, and evaluate a social-norms campaign
- Increase awareness of CORE and NCHA data by purchasing "real-time" I-clickers to provide interactive learning

#### Time Frame

- Winter Semester 2012 students design social norms campaign specific to EMU freshman
   Purchase "real time" I-clickers to help in the dissemination of our NCHA and CORE data
- Spring/Summer 2012 Print social norms media
- August 2012 Implement
- September 2012 Evaluate

#### Collaboration

- Dr. Jeff Schultz's HLED 490-Drug Use and Abuse class
- Social Norms Assignment:

  Students will work with the Snow Health Center to develop a social norms campaign addressing binge drinking on the EMU campus.

- Share current data specific to EMU and define/discuss what a social norms campaign is
- Review data and highlight key statistics
- Identify themes representing EMU
